2. The Event

Venue:	Gibbston Valley (GPS -45.016, 168.928)
Length	1.6km track in an undulating grass paddock
Scrutineering/Documentation	11:00am (22 nd & 23 rd)
Start:	12:00pm (22 nd & 23 rd)
Entry fee:	\$40.00 - QCC Member Price \$50.00 – Alternative Club Member Price
Classes -	B 0 – 2000 C 2001 + D 4WD

Cross Cars must let us know as soon as possible that they intend to enter, so we can issue a bulletin amendment. They will be able to race for Class points only and will not be eligible for club points or overall results on the day.

3. Competitor requirements

Drivers must hold a **minimum current drivers license or MSNZ M license.**

- All competitors and passengers must wear cotton protective overalls or better approved garments. Any clothing worn under overalls must be either cotton, wool or an approved garment, this includes socks. Leather or approved footwear must be worn.
- All competitors and passengers must wear complete covered in footwear.
- All competitors and passengers must wear a protective helmet.
- All passengers and their driver must sign a passenger declaration form. Passengers in caged vehicles only.
- These requirements are in line with the new amendments to the clothing changes by msnz.

4. **Vehicle requirements**

All Vehicles will go through scrutineering. Vehicles must be in a warrantable condition.

Queenstown Car Club does not condone the use of race vehicles which are not registered and warranted to be driven to any of our events. If your vehicle does not meet these standards, they must be trailered or towed. Any race vehicle that is driven to scrutineering or an event which is not road legal will be denied entry, and they will forfeit their entry, and will not receive a refund. It could also result in being banned from future events.
